

Innocence is strength A COURSE IN MIRACLES

A story ...

Yusuf Salaam was 15 years old when he was arrested along with 4 other teenagers of the same age and another who was 16. They were arrested on the allegation of raping a woman jogger in New York's Central Park. The case was brought against them by the New York Police. This was in April 1989.

The black and Hispanic teenagers were sentenced to the maximum allowed for juvenile crime - 5 to 10 years. They had all pleaded 'not guilty' despite having 'confessed under coercion' (as argued by their defence counsels) to the police. The story and the case became famously known as the *Central Park 5*.

On May 1, 1989, a man called Donald Trump, took out a full-page advertisement in response to the incident in four newspapers including the Daily News. In it, he called for the return of the Death Penalty.

In his advertisement and in several interviews that he gave during that period, Donald Trump maintained that criminals like the the charged teenagers deserved the highest form of punishment and his and others' hatred. It has been widely commented that, together with the media fueled fear-mongering around the safety of joggers in New York's parks, this advertisement played a significant role in the conviction of the teenagers.

What has happened to our City over the past ten years? At what point did we cross the line from the fine and noble pursuit of genuine exist liberties to the reckless and

on whomever they encounter. At what point did we cross the line from the fine and noble pursuit of genuine civil liberties to the reckless and dangerously permissive atmosphere which allows criminals of every age to beat and rape a helpless woman and then laugh at her family's anguish? And why do they laugh? They laugh because they know that soon, very soon, they will be returned to the streets to rape and main and kill once again — and yet face no great personal risk to themselves.

Mayor Koch has stated that hate and rancor should be removed from our hearts. I do not think so. I want to hate these muggers and murderers. They, should be forced to suffer and, when they kill,

they should be executed for their crimes. They must serve as examples so that others will think long and hard before committing a crime or an act of violence hard before committing a crime or an act of violence. Yes, Mayor Koch, I want to hate these murderers and I always will. I am not looking to psychoanalyze or understand them, I am looking to punish them. If the punishment is strong, the attacks on innocent people will stop. I recently watched a newscast trying to explain the "anger in these young men". I no longer want to understand their anger, I want them to understand our anger. I want them to be afraid.

In December 2002, following the confession to the rape by a man who was already in prison for other crimes, the five teenagers, now grown men, were exonerated. It didn't change the fact that Yusuf Salaam had, by then, spent almost 7 years in prison, having gone to prison at 15 and been released at the age of 22.

The continuing story...

In recent times, when asked whether he would apologize for what he had said about the Central Park 5, Donald Trump refused to, asserting that the exoneration was wrongful, that the new evidence was contestable and that he still believes they are guilty.

On April 4, 2023, Donald Trump was arraigned in the same New York courthouse where the Central Park 5 had been tried. 34 charges have been brought against him in one of several law suits that he currently faces in New York and in the state of Georgia. Donald Trump, as you would know, was President of the United States of America from 2017 to 2021 and is currently making a second presidential bid.

On April 4, 2023, on the day of Donald Trump's arraignment, Yusuf Salaam posted an 'advertisement' in his Twitter feed that looked similar to the one that Donald Trump had posted in the Daily News back in 1989. But his advertisement said something very different.

BRING BACK JUSTICE & FAIRNESS. BUILD A BRIGHTER FUTURE FOR HARLEM!

On May 1, 1989, almost thirty-four years ago, Donald J. Trump spent \$85,000 to take out full-page ads in The New York Times, New York Daily News, New York Post and New York Newsday, calling for the execution of the Central Park Five — an act he has never apologized for, even after someone else confessed to and was convicted of the crime, the convictions of all five of us were overturned, and we were renamed the Exonerated Five.

Instead, Mr. Trump has often doubled-down. A few weeks after taking out the ad, he went on CNN and stated: "I hate these people and let's all hate these people because maybe hate is what we need if we're gonna get something done."

Even after our exoneration and acknowledgment by the government that we had been wrongfully convicted, Mr. Trump continued to incite animus against me, my peers and our families. In 2013 – over a decade after our exoneration – Trump called the Ken and Sarah Burns Central Park Five documentary "a one-sided piece of garbage," and when asked how he felt now that we were shown to be innocent, responded: "Innocent of what?"

In 2014, the City of New York finally reached a settlement with the members of the Exonerated Five, awarding us compensation to help us rebuild our lives after so many years were taken from us. But even that acknowledgement from the city wasn't enough for Trump to see five young Black and Latino men as anything other than criminals, saying "settling doesn't mean innocence."

Now, after several decades and an unfortunate and disastrous presidency, we all know exactly who Donald J. Trump is —a man who seeks to deny justice and fairness for others, while claiming only innocence for himself.

Being wrongfully convicted as a teenager was an experience that changed my life drastically. Yet I am honored when people express how deeply they connect with my story.

It matters because, while my experience may have been extreme, I have lived through a form of trauma that many of us experience in some way every day throughout our country. My past is an example of systemic oppression imposed by the injustice system. But the problems our community faced when my name was splashed across the newspapers a generation ago — inadequate housing, underfunded schools, public safety concerns, and a lack of good jobs — became worse during Donald Trump's time in office.

I am trying to change that, by working with so many other dedicated community members to build a better future for everyone, both here in Harlem and across the country.

Here is my message to you, Mr. Trump: In response to the multiple federal and state criminal investigations that you are facing, you responded by warning of "potential death and destruction," and by posting a photograph of yourself with a baseball bat, next to a photo of Manhattan DA Alvin Bragg. These actions, just like your actions leading up to the January 6 insurrection at the U.S. Capitol, are an attack on our safety.

Thirty-four years ago, your full-page ad stated, in all caps: "CIVIL LIBERTIES END WHEN AN ATTACK ON OUR SAFETY BEGINS."

You were wrong then, and you are wrong now. The civil liberties of all Americans are grounded in the U.S. Constitution, and many of us fight every day to uphold those rights, even in the face of those like you who seek to obliterate them.

Now that you have been indicted and are facing criminal charges, I do not resort to hatred, bias or racism – as you once did.

Even though thirty-four years ago you effectively called for my death and the death of four other innocent children, I wish you no harm.

Rather, I am putting my faith in the judicial system to seek out the truth. I hope that you exercise your civil liberties to the fullest, and that you get what the Exonerated 5 did not get – a presumption of innocence, and a fair trial.

And if the charges are proven and you are found guilty, I hope that you endure whatever penalties are imposed with the same strength and dignity that the Exonerated Five showed as we served our punishment for a crime we did not commit.

And, as <u>Annie Lennox and Dave Stewart so beautifully sing</u>, it is the world of illusions.

What does that mean?

It means that it is a world *conditioned* and *constructed* by our thinking, by our perceptions, our beliefs and our values. We see as we believe. And we have learned what to believe, what to see and what to value.

The world of Love

The world of love, on the other hand, the spiritual world, the world of Innocence, the world of miracles, is the world that requires no belief. Rather, it is a world that is unconditioned by, and impervious to, human thinking and all its judgements. It is naturally and eternally radiant with goodness, peace, infinite possibility, the power of Love, and the abiding and undeniable freedom from all suffering.

You see, in this world of Love, all of us, including the most vile perpetrators of whatever atrocities they are accused and found guilty of (or not), are innocent. Why? Because they are created in Love, of Love and from Love.

AND

Because everything that is not done out of Love is, by default, done out of Ignorance.

And what is this Ignorance?

Not stupidity.

What then?

The failure to recognize who and what we truly are, beyond all our beliefs, all our perceptions, all our conditioning by our life experiences.
